Agnès Collier: Political changes and innovation in the UK in the 21st century (9h)

In this post-Brexit post-Covid era, with the fear of growing populism in Western Europe, the purpose of this course is to examine the political changes which have affected the United Kingdom since the 1990s. The notion of change covers the two following aspects:

- institutional changes, that is how the British Parliament has been increasingly challenged by competing institutions at the supra-national (EU) and at the sub-national level (especially Scotland and Wales), with Brexit introducing additional challenges to the constitutional principle of parliamentary sovereignty.

- party changes, i.e. in the party system as well as ideological and organisational changes within parties themselves, prompted by the need for more internal democratisation in order to restore an allegedly damaged relationship between people and politicians and improve political participation at all levels. The hypothesis of populism in the UK party system will be examined.

Bénédicte Coste : Translations in fin de siècle periodicals (9h)

This seminar explores the neglected area of translation in literary periodicals of the fin de siècle (1880-1900) and specifically engages with ENG-FRE and FRE-ENG translations in some literary organs. After a presentation of periodical culture in both France and Britain, the seminar engages with locating translations within periodicals. It also fosters a discussion on translation itself through various instances. Workshops enable students to assess translations and see their variability.

Reading material and bibliography will be posted on Plubel.

Mélanie Joseph-Vilain: Monstrosity and Gender (9h)

The purpose of the course is to analyse the evolution of cultural and literary representations of monstrous femininity, especially in colonial and postcolonial contexts. It will rely on the ways in which monster theory has been influenced by gender theory, which has helped understand how women from colonial and postcolonial backgrounds have been represented in western works. The corpus will include visual and

literary representations of the "monstrous female", from Saartjie Bartman, the "Hottentot Venus", to more recent reappropriations and reinterpretations.
